Bidding is open to all eligible as per bidding document.
2. **Mandandepur Municipality** invites electronic bids from eligible bidders for the construction of **Mandandepur Municipal Hospital** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
3. Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRS 11,09,53,277.00**
  - Minimum Work experience of similar size and nature: **1 number of minimum 5 bed capacity Hospital project and value of minimum Nrs. 8,87,62,621.00**

The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 hours on 15/04/2020** at the office of **Mandandepur Municipality, Mahadevsthan Kavrepalanchowk**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRS 37,61,316.00** which shall be valid for 30 days beyond the validity period of the bid.
