Sealed Quotations shall be opened in the presence of Bidders representatives who choose to attend on 2 hours after Quotation submission deadline at the office of Mandandeupur Municipality, Mahadevsthan, Kavre, Nepal. Sealed Quotations must be valid for a period of 45 days counting from the day of Quotation opening and must be accompanied by Quotation security amount (mentioned above), which shall be valid for minimum 30 days beyond the Quotation validity period. The scanned copy of Quotation security should be uploaded in the e-GP system during Quotation submission for online submission and the original quotation security should be included along with quotation offline submission.
