Online bids shall be opened in the presence of Bidders representatives who choose to attend on 17-03-2019 14:00 to 15:00 hours at the office of Mandandepur Municipality, Mahadevsthan, Kavre, Nepal. Online bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security amount. which shall be valid for minimum 30 days beyond the bid validity period. The scanned copy of bid security should be uploaded in the e-GP system during bid submission.
