4. Interested bidders should submit online bids through e-procurement portal http://www.bolpatra.gov.np/egp only on or before 4th Oct 2021, 12:00. Bidders are required to follow the electronic bid submission procedure as specified in e-GP System Operating Guideline 2074 and User manuals issued by PPMO which are available in e-GP system. Online bids shall be opened in the presence of Bidders representatives who choose to attend on 4th Oct 2021, 14:00 hours at the office of Mandandeupur Municipality. Online bids must be valid for a period of 120 days counting from the day of bid opening and must be accompanied by bid security amount (mentioned above), which shall be valid for minimum 30 days beyond the bid validity period. The scanned copy of bid security should be uploaded in the e-GP system during bid submission.

5. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
